

2014 Farm Bill – Decision Making Tool Workshops Planned for Malheur County – OSU Extension & USDA-FSA



The new 2014 Farm Bill includes many changes and some programs will require action by owners and producers within the next few months to make certain decisions on each FSA farm. The primary goal of the Farm Bill is to provide a farm income safety net that helps manage risk associated with low yields and/or low revenue while working in combination with primary and/or supplemental crop insurance coverage.

The new replacement Farm Service Agency (FSA) programs include the **Agriculture Risk Coverage** (**ARC**) and **Price Loss Coverage** (**PLC**) Programs. So, you will have a one-time opportunity to update yields (decision by the owner), reallocate base crop acreage (decision by the owner) by February 27, 2015, and to choose between ARC or PLC programs (decision by producer). Two different online tools have been developed by Texas A&M and the University of Illinois to help you explore the different programs and estimate the potential safety net payments your FSA farm(s) might receive during the life of the Farm Bill (through 2018). Potential participants do have time to research both the ARC and PLC programs prior to selecting a program. You will then have to sign up at your local FSA office before the March 31, 2015 deadline.
